

Official Rules

Description of the Sweepstakes

Elimination

The Sponsor further reserves the right to disqualify any entry that it believes in its sole and unfettered discretion infringes upon or violates the rights of any third party, otherwise does not comply with these Official Rules, or violates U.S. or applicable state or local law.

Winner Selection

The Winner will be selected by random drawing and is subject to verification by The "Sponsor." Entrants must fill out the entry form with in entirety with their accurate information. Decisions regarding the Sweepstakes made by The Sponsor are final and binding.
